Presentation and Discussion on Recruitment of Paid-on-call Firefighters & Staffing

Anne Campbell – HR Director gave a presentation on the status of recruitment of Paid-on-call Firefighters and overall staffing levels. She mentioned that the Brighton Area Fire Authority has kicked off the 2022 Paid-on-Call Hiring Process. In order to aid the Fire Authority in selecting the highest quality employees, the following process is utilized: Background Investigation, Online Competency Exam, Two Rounds of Oral Interviews, Physical Agility Test and Physical Examination.

As of July 7, 2022, we have received 15 paid-on-call applications for consideration. Application deadline for this hiring process is July 18, 2022. Brighton Area Fire Authority utilizes various recruitment channels to reach and hopefully inspire our residents to serve as paid-on-call firefighters. From station banners, job fairs, social media platforms, direct mailers, our goal is to reach as many of our residents within our fire jurisdiction. With the support of our municipalities, we have sent out 20,044 recruitment inserts with the summer tax bills. Our goal is to have received 25 applications before the onset of the process.

Presentation and Update on Fire Station 33 (Weber) Construction Project

The Construction at Fire Station 33 continues and the following updates:

- The exterior pole-barn storage is nearing completion. A change order for electrical service is under development and subject to changes.
- Main building electrical panels and sub panels continue to create a delay in the overall project. Estimated delivery is anticipated to be in September.
- Exterior finishes, landscaping and bay painting continue.
- Interior finish components continue to arrive.
- Estimated occupancy mid-late October 2022.
- Based on current change order and financial reports the project is under the budget of \$4,536,610.00

Good of the Order

Our Livingston County Firefighter Training Academy as well as our Howell High School Fire Academy have just concluded and both had very good pass rates.

Our crews have been busy. Recently we've had a home fire, a double extrication and a roll-over semi incident.

The Fire Authority is looking at the possibility of purchasing BS&A accounting software. Also, our Incident Management software will no longer be NEMSIS compliant come January 2023 so we will be changing Incident Management software in the very near future.

Fire truck purchase is still in the Chief's purview but with a two-year lead time at an estimated cost of \$700,000 with a possible increase of up to 20% nothing has been decided yet.
