2023-2024 Full-Time Benefit Summary Amendment

In an effort to attract and retain the highest quality personnel, administration is recommending the following amendment to the 2023/2024 Full-Time Benefits Summary:

• Vacation Modification Request (First level vacation tier only, pg. 7)

New Hires would receive 136 hours of vacation, prorated based on hire date. Upon separation, employees who work less than 12 months of continuous full-time employment would not be paid out credited vacation time nor would employees be discharged for cause.

Current Vacation Policy

New hires earn 8 hours of vacation per month. This time is credited the following January 1st. Additional earned vacation time will be credited at the 12-month anniversary. Total of 96 hours of vacation.

Soup Out will be held on February 15th at Station 31.

We had a fatal house fire on Dec. 20th on Hughes Road. Although our crews did a phenomenal job on scene, the fire was 50% involved with fire and smoke coming out of the windows upon arrival. Crews attacked the fire and discovered a victim lying in bed in one of the bedrooms. They removed the victim but we were unable to save his life.

Mike Corrigan asked if we knew the condition of the person who was injured in the motorcycle crash back in August. Chief responded that we have not received an update on his condition but he was alive when he was transported to the hospital.

Mr. Riker asked about the pedestrian that fell on to Grand River from I-96. Chief said that the man's vehicle had broken down on the overpass at I-96 over Grand River and the man thought he could walk down to Grand River from the overpass but slid down the hill near Grand River but he was fine.

Mr. Riker asked how the new squads were working out. Chief said that we're very pleased with the new rigs. Crews transported a patient once thus far, when we were requested by LCEMS due to the fact that they were out of rigs.
