DRAFT Budget Presentation for FYE June 30, 2023

Presentation of DRAFT Operating and Capital budgets for fye June 30, 2023. The presentation will cover the anticipated revenue and expense changes for the fiscal year. Final budget will be submitted to the Board at the May 2022 Board meeting.

Highlights include:

- Based on recommendation from the personnel committee; a 5% cost of living increase for all employees including BAFA Board and Deputy Treasurer, along with a 1% increase in the defined contribution match.
- Continuation of apparatus and staff vehicle replacement in accordance with our capital improvement plan.
- Finalize construction of Fire Station 33 (Weber).
- Begin development of Fire Station 31.
- Additional full-time staff for coverage of current shifts, that are limited due to paid on call availability.

Good of the Order

Chief O'Brian stated that Station 33 is slated for completion in August/September of 2022. There's a delay in delivery of the electrical equipment but there's a plan in the works to remedy the situation.

Staff is preparing for the July 4th parade.

This year we will be hosting a First Responder Youth Summer Camp in partnership with Brighton City Police beginning June 16th. It will consist of 3 days of Police Camp and 3 days of Fire Camp with a combination BBQ at the end of the camp.

BAFA will be supporting Brighton High School in May for their "Mock Accident" program that they sponsor to show the consequences of driving under the influence of alcohol or drugs, texting or improper use of seat belts. Shawn Pipoly noted that he's trying to get a simulator brought in so the students can get a feel for what can happen when you lose focus or take your eyes off the road.
