EXPLANATION OF TOPIC

Fire Authority staff has been developing Fire Station 33 over the past year with our architecture firm Partners In Architecture. Comprehensive drawings and submittal were posted for Bid on MITN-Network.

Nine Sealed bids were received on June 4, 2021 and results were publicly posted on MITN. On Thursday, June 17, Supervisor Michel, Supervisor Rogers, our Architecture Firm as well as Fire Chief O'Brian, and Deputy Chief Evans met with 4 firms (NRC, Brivar, Sorensen and Creative Construction Concepts) for interviews to review qualifications, bid pricing, alternatives and review the project.
