Chief O'Brian reminded the Board of our annual Soup Out, which will be held February 18, 2016 from 11:00 am - 1:30 pm at Station 31.

Chief O'Brian mentioned that there was a large power outage in the City last night resulting in nine BAFA responses to incidents. Calls ranging from smoke investigations to power panel issues etc. The BECC building's generator never started, which also runs portions of communication for the County 9-1-1 system. As a result portions of the fire department paging and some 9-1-1 services were down temporarily. We were also called to assist Hamburg Fire Department on a fire scene.

The Chief also mentioned that he will be meeting with the three municipalities regarding the need for some capital improvements at the stations.

Todd Smith mentioned that he would like another copy of the report that the Chief had provided showing the various functions of the fire department ie: inspections/smoke alarm installs/public education etc. so that Genoa Twp. could post it on their website to inform the public of all the great things the Fire Department does for the community.

He also suggested including the report mentioned above as part of the press release to highlight the diverse roles, the Fire Department plays in the community.
