## Preliminary Budget Presentation for fye June 30, 2020

Our two Fire Academies are nearing completion. We know the Howell High School Fire Academy and the Livingston County Firefighter Training Academy will produce some new firefighter candidates come July.

Deputy Chief Mike Evans and Lt. Rob Furlong are leading the charge on getting our new incident reporting system (Alpine) up and running.

The purchase of the Weber Road properties in Brighton Township has been completed and we've received the title work. Thank you to Neal Nielsen for his assistance on handling this matter.

Anne Campbell is spearheading a "Girls on Fire Camp" June 17-19 from 8 am -3 pm at Station 32. The camp is open to Livingston County teen girls ages 14-18 where they will learn CPR, self-defense tactics, leadership and firefighting skills. Cost is \$50.

Patrick Michel stated that as the father of a 15 year old daughter, he saw the "Girls on Fire Camp" as a great program to introduce young girls to the possibility of a firefighting career, while promoting their development in leadership, teamwork and self-confidence. This is a great opportunity to break down the stereotypes in this historically male dominated career and show that girls can be whatever they want to be.

Lucille Weaire asked the Chief if he's received feedback on the May 7<sup>th</sup> Fire Millage election. Chief O'Brian responded that he's been talking to community groups and getting the word out and answering a lot of questions. He's received a lot of positive feedback.
