Our crews have run on 6 critical care incidents since the last board meeting. One was a crash involving two motorcycles, with both patients incurring severe injuries. Our crews and the EMS paramedics did a great job on the scene.

Our crews also responded to an incident involving the son of one of our firefighters. Luckily the patient was transported to the hospital and is doing well.

There has been an increase in vehicle crashes on Old US-23 between Hilton and Skeman. Due to the construction on US-23 freeway a lot of commuters have decided to travel Old US-23 and folks are driving at freeway speeds instead of the posted speed limit causing accidents. Patrick Michel stated that his daughter was the victim of one of these incidents at Old US-23 & Skeman, fortunately she was not injured but her vehicle was severely damaged.
