Request to Purchase Financial Software from BS&A

The Fire Authority is currently utilizing Quickbooks for our book-keeping and financial software. The main files are utilized by our Deputy Treasurer (Robin Hunt) and copies are sent monthly to the fire department for reporting.

The current system does not allow for integration of purchase orders, approval tracking and delays in realtime data on our financial decisions. This requires staff to utilize additional spreadsheets and other measures for financial documentation.

Staff met with BS&A to review the software with Robin Hunt. The new software will tackle the integration we have been looking for and allow us to be more efficient, with real time reporting on our financial aspects.

Motion by <u>Bill Rogers</u> supported by <u>Mike Corrigan</u> to purchase financial software and services from BS&A Software at a cost of \$25,845 for the first year. Thereafter there will be an Annual Cloud Service fee of \$4,785 and Hosting fees of \$400.

Request to Purchase Two Replacement Staff Vehicles

The fire department was notified yesterday, August 9, 2022 that the State BID pricing from Ford Motor Company for 2023 bid pricing and orders is open until August 19, 2022. We are looking to replace our Inspector's 2015 & 2017 Ford Expeditions.

The vehicle spec and information are for the 2023 F-150 Police Responder SuperCrew on the Government Pricing (Macomb Bid). The unit includes base model convenience and upgraded safety and convenience features and tow capabilities.

The price breaks down at \$50,534 per truck or \$53,384 per truck with a 5 year 100,000-mile warranty added. We in turn will be selling the 2015 Ford Expedition along with a 2013 Chevy Tahoe.
