Introduction and Oath of Office for New Fire Protection Specialists

Chief introduced our four new Fire Protection Specialists, Corey Laber, Jeremy Griffin, Philip Mattern, and Justin Thornton to the Board. They will be starting their full-time positions on December 29th, 2019, Tara Brown, the Clerk from the City of Brighton, administered the Oath of Office.

Staffing Changes Effective December 29, 2019

As part of our strategic planning and award of the FEMA-SAFER Grant, the Fire Authority will be adding staffing to an additional station for a 24-hour schedule.

The Fire Authority currently staffs Fire Station 31 with 2 people on a 24-hour basis. During the day (6a-6p) the Fire Authority staffs a total of 6 people on duty, with a combination of full-time, paid-on-call and part-time staffing.

Effective Sunday, December 29, 2019, the Fire Authority staffing numbers will increase during night time operations.

- (9) Full-Time Staff will be assigned 24-hour shifts based on a 56-hour work week
- (1) Full-time Fire Protection Specialist will be assigned 12-hour shifts (day time) typically M-F.

These changes will allow us to staff 6 people during the day 6a-6p and then 4 people from 6p-6a. Staff will be strategically located at Fire Station 31 and Fire Station 35 (will shift to 34 after construction is complete)

Recommendation to Award Contracting and Construction Services for Fire Station 34 Addition

The Fire Authority, working with Partners in Architecture has solicited bids for construction as part of an RFB process. The bids were publicly posted on Bid Net and included a pre-bid walk-through with interested contractors, the public bid opening was held on Friday, December 13, 2019.

Fire Authority Staff, as well as Partners in Architecture and board representatives, conducted interviews with qualified contractors on Monday, December 16, 2019. The Fire Chief reviewed the process and highlighted the two lowest, qualified bids.
