### Request to Purchase Mobile and Portable Firefighter Radios

This request is for 10 new Motorola APX 6000XE portable radios, all radios have the most recent required features added, TDMA and encryption.

The pricing is on a multi-department purchase which gets us pricing of \$7207.90 per radio. This price includes radio, antenna, charger, 2 batteries, and programming from the State of Michigan. Our total cost of this purchase is \$72,076.90. This request is part of the FYE 2024 Capital Budget.

As a note, we currently have 13 non-ruggedized APX portable radios assigned to apparatus including our Tankers, Brush, and Utility trucks which do not meet the durability requirements for our firefighters and are subject to frequent failures.

Mobile radios needed: three Motorola APX 7500, at \$3225.00 each, including shipping and programming from the State of Michigan. These radios will be installed in the two Squads and the new Tanker 34. One

Motorola APX 6500 will need to be purchased and this will be installed in B/C 3 for a second mobile radio at \$2450.00 including shipping and programming from the State of Michigan. These radios will be pre-owned.

## 2023 Annual Report Presentation

Chief O'Brian presented a draft of the 2023 Annual Report and highlighted the various aspects of the organization. Here are some of the highlights:

- BAFA responded to 2535 calls for service in 2023 which was an increase over the previous year. 50% of all calls were EMS incidents and 61% of the time BAFA arrived prior to EMS.
- We had 1 death due to a home fire in 2023.
- Station 31 is our busiest station, February is the busiest month & Mondays & Fridays are the busiest days of the week.
- BAFA completed a department EMS upgrade from EMS non-transport to EMS transport with the addition of two new squads and reaffirmed its commitment to enhancing EMS skill sets striving to deliver outstanding EMS care to residents, employees and visitors in the community.
- Recruitment & retention has been a priority for BAFA. Our paid-on-call applications were up 25% from 2022, we hired 15 new paid-on-call firefighters, 2 new Junior cadets and hired 3 full-time staff to replace staff that recently retired; Deputy Chief, Howell High School Academy Instructor and Administrative Assistant.
- BAFA hosted another successful First Responder Youth Summer Camp with a total of 20 campers, 13 boys and 7 girls ages 14-18.

- Community Risk Reduction and Fire Prevention efforts have been a huge focus in 2023 with crews visiting various businesses, daycares, schools, senior facilities spreading our fire prevention message.
- Training has always been one of BAFA's strengths, we recognize the need to remain solid on core skills as well as various high hazard/low frequency incidents. Staff continues to train weekly on various topics including: CPR, Medical training, water & ice rescue, fire suppression & Haz-mat. In 2023 staff logged 22,480 training hours.
- The Livingston County Firefighter Training Academy led by Chief of Training Greg Mowbray graduated 28 cadets from 7 area departments in 2023.
- The Howell High School Fire Academy XI led by Lt. Chad Nickels has 23, 11<sup>th</sup> & 12<sup>th</sup> grade students from various school districts enrolled in the program. Lt. Nickels acquired a State of Michigan 61c grant facilitated by LESA to acquire new firefighting gear, props and firefighting hand tools for the students.
- BAFA is very involved in the various County wide "Special Response Teams": Technical Rescue, Dive, MI Task Force I & Haz-mat.
- New apparatus: 2023 Pierce Tanker, 2 remounted squads to replace two 2005 mini rescues, a 2022 Ford F-350 pick-up and two 2023 Ford F150 pick-ups for the Inspectors.
- Station 33 became operational in January 2023 and will be staffed beginning March 3<sup>rd</sup>, 2024.
