Request to Purchase Replacement SCBA Bottles

In 2018 the Fire Authority replaced the SCBA back frames and face pieces due to technical issues with our previous air packs (SCBA). The bottles which have reached end of life are due for replacement starting in March. We are looking for authorization to purchase 117 cylinders for the Avon SCBA's at a unit price of \$708.75 each.

The vendor has been holding 2018 pricing as part of the changes made in 2018 and the pricing proposed is \$300-\$500 under other quotes received.
