Transfer Ownership of Fire Station 31 from the City of Brighton to BAFA

No action was taken on this. The Chief is waiting to get the "Agreement for the Transfer of Fire Station 31" back from the attorney after final review.

Station 31 Feasibility study from Brivar Construction

This topic authorizes the Fire Chief to begin the needed work on a feasibility study for renovating, adding, and/or altering Fire Station 31 with Brivar Construction.

FEASIBILITY STUDY intends to conduct the following preliminary work for BAFA to determine the Conceptual Site Plan for the proposed construction.

Brivar has completed the work at Fire Station 34 and 33 in the past and has served as a partner to BAFA. This feasibility study is important to determine our next actions including:

- Develop base drawings for site plan and overview architectural drawings
- Development of project budget and schedule
- Alta Study, Soil Borings, and technical analysis of the site are needed for consideration of next steps.

- BAFA has utilized multiple attorneys for some time. Howard Shifman serves on labor related issues and Fred Lucas is our General Counsel.
- The cost for all terrain tires for a large F350 truck are more expensive than ordinary tires.
- Multiple board members stated that they review the check register every month in great detail.
- Heavy truck repairs have been performed by Corrigan Oil. Their staff will prioritize BAFA apparatus and rates are comparable to other providers. In addition, they are authorized to work on emergency apparatus.
- Chairman Muzzin said that he consulted the City attorney when he was Mayor, if it would be inappropriate for him to vote on spending issues related to Corrigan Oil since he worked for Corrigan and the attorney said that it was not a conflict of interest.
