Update on Design of Fire Station 33

BAFA staff are continuing the development process of the Weber Road Fire Station located in Brighton Township. Staff are meeting every two weeks with Partners in Architecture and have narrowed down a basic floor plan.

- Facility just under 10,000 square feet with 3 drive-through apparatus bays.
- Forward facing with direct access from Weber Road.
- Water service extended through Brighton Township property from Old US-23.
- Formal Survey under development from Boss Engineering.
- Soil borings to be conducted in next 30 days.

Anticipated time frame:

- Submit for Brighton Township Planning Commission approval in December 2020.
- Prepare for bid documentation in Early 2021.
- Estimate beginning of construction in early summer 2021.
