### Station 33 Construction Update

Chief O'Brian provided an update on the construction project for fire station 33

- Anticipated land use permit will be issued by Brighton Township. This will allow Partners in Architecture to begin the construction review and permit process with Livingston County Building Department.
- Brivar Construction is beginning to mobilize on the site and begin site preparation. Initial work will include the soil erosion matters, land clearing, as well as removing soil piles.
- Bid Pack 2 has been approved by Brighton Township and the Livingston County Water Authority. This additional work includes the removal of spoils from the Brighton Township parcels and a water main extension on Thomas avenue for LCWA.
- Weekly construction meetings between PIA, Brivar, and BAFA have started. This includes reviewing construction submittals, progress update as well as change orders.
- The vacation process of Thomas and Sanders Ave. continues with Harris and Literski.
- Brivar Construction has started ordering the materials. Steel is expected mid-January.

#### Good of the Order

The 9/11 - 20<sup>th</sup> Anniversary Memorial Commemoration is scheduled for Sept. 11<sup>th</sup> at 8:30 am at Station 31 located at 615 W. Grand River in Brighton.

Friday, September 10<sup>th</sup> Brighton High School football will be playing Hartland. The theme is Red, White & Blue. Brighton Fire & Hartland Fire will have their ladder trucks on the sidelines displaying the American flag between the top of the two ladders. September 10<sup>th</sup> and 11<sup>th</sup> is the Smokin Jazz & BBQ Blues Festival in downtown Brighton.
