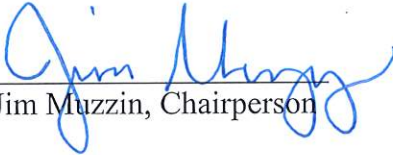
Chief O'Brian answered Susan Walters' question regarding the payouts on the check register.
