Update on Station 31 Construction Project

The following updates have occurred for the addition/reconstruction of Fire Station 31:

- The City of Brighton planning commission meeting on the amended site plan is scheduled for September 15, 2025.
- The contract with Brivar Inc dated August 30, 2025 has been executed.
- The Congressional grant (Grant Package for : B-22-CP-MI-0459), is now showing as executed and the environmental review is in process.
- The review with Fika and Brivar construction is 30% complete.
- The move out process has begun, including all equipment and repositioning of administration and duty crews/paid on call.

Update on 96WB Incident where Fire Dept. Vehicle was Struck

On Sunday, August 30, 2025 around 6:05 am one of our Staff Vehicles (Chief 32, Chief Mowbray), was aiding an existing vehicle roll-over on I96-WB over US-23. The location of the incident caused difficulty in traffic, having sufficient warning to slow down.

Chief Mowbray was parked at the bottom of the ramp with his emergency lights on, and Chief Tester was approximately 1100 ft. in front of him to reduce traffic to one lane. Chief Mowbray's vehicle was struck from behind by a vehicle that went around the traffic and directly into his vehicle, causing a second accident.

The organization quickly mobilized to support both incidents and work to provide EMS Care, and extricate the victim from the secondary accident. Chief Mowbray was transported to St. Joe Ann Arbor and the patient was transported to U of M.

Discussion on the Need for Repair, Maintenance and Replacement of Communication Systems

The Fire Authority has been working with Livingston County Central dispatch and local fire departments as well as Livingston EMS due to issues with alerting of Fire and EMS through VHF paging.

We are experiencing incidents where staff do not receive the page and rely on backup systems such as alerts on our phones or phone calls by staff. Lack of system maintenance, strategic planning, and repair/replacement has left our VHF paging as well as day to day communication (800 MHz) below standards and affecting our ability to communicate in emergency situations.

Chief O'Brian in coordination with the local communities, Livingston County EMS and law enforcement agencies are requesting that Livingston County Board of Commissioners approve and fund the proposed tower and radio upgrade for 800 MHz immediately with full coverage as recommended by Motorola.

Long-term, Livingston County should approve a dedicated millage and/or increase 9-1-1 surcharge funding to properly repair, replace, staff, and fix radio communications. This includes a long term strategy beyond VHF for alerting firefighters and EMS.
