VHF System Repair Update

In addition to the item listed in the agenda item, the Fire Chief provided an update to the communications system.

The 800mhz project had a kick-off with Motorola, Livingston County Central Dispatch and local public safety. Chief Tester attended the meeting. A brief update was provided on the project that occurred this week.

The Fire Chief expressed his gratitude for Congressman Tom Barrett. Although we don't have the full scope, it appears funding will go towards the CAD project.

The VHF system was under repair this week by technicians from Motorola. The system was tested on Wednesday and audio coverage as well as tone quality appear to be back at normal levels. The Fire Chief expressed his thanks to BAFA staff and Livingston County Central Dispatch for working diligently on the repair.

Appointment of Citizen at Large

The Board deliberated on three candidates who applied. The Fire Chief gave an overview of the three candidates. Discussion also covered the posting of the material on the Authority web-page as well as the Authority Facebook Account for over two weeks.

Board members discussed the candidates and the role of the Authority Board, as well as the possibility of conflict with existing fire service members and how the Authority is currently operating. It was acknowledged that Mr. Corrigan's institutional knowledge as an original board member is an asset to the Authority Board on process.
